## Clause No. 1 Subject of the Contract

1. The Author is hereby obliged to submit the copyright upon the order from the Publisher of text of catalogue

Polish painting around 1900 /Pol'ská mal'ba okolo 1900

Introductory essay
Total number of pages 23 pp

2. The Author shall deliver the above mentioned text to the Publisher in the agreed size, in the Polish language. The Author is asked to provide a list of references attached to the texts as well as suggestions for illustrations. In the case the Author does not have the copyright for all parts of the texts he shall announce to the Publisher the name and the address of the person having the copyright.3. The Author hereby declares that the copyright transferred by this agreement belongs exclusively to him with no restrictions and he is reliable for all damages, which might occur to the Publisher in the case this declaration is not trustworthy.

# Clause No. 2 Delivering and accepting of the texts (icl. illustration proposal etc.)

1. The author shall deliver the work to the Publisher at the latest date on April 30th, 2011. The Author is asked to accept the editorial suggestions as prepared by the Publisher, in case these will be formulated by the responsible editors or translators.

## Clause No. 3 Delivering of the publication and publication rights

- 1. The Publisher is hereby obliged to provide one copy of the catalogue immediately after its publication.
- 2. The Publisher shall have the right to print a reasonable number of copies of some parts of the catalogue for promotional purposes and/or publish them in promotion materials. Remuneration for this activity is included in the agreed author's remuneration.

#### Clause No. 4 Author's remuneration

- 1. The Publisher will pay the Author the agreed sum of **575 Euro** (25 Euro for one standard page) for creation of the texts as well as for the allowance to issue it according to the rules stipulated in this agreement.
  - 2. The remuneration is due to be paid within 30 days from delivering the essay agreed in the agreement or accepting this by the editor of work.
    - 3. Payment: to the Author's bank account

## Clause No. 5 Special provisions

- 1. This agreement is executed in 4 copies whereby 3 copies will be received by the Publisher and 1 copy by the Author.
- 2. Rights and duties ensuing from this agreement with the exception of liability to personally create the work of art are referred to legal successors in title of both contracting parties.
  - 3. Changes and additions to this content shall be executed exclusively upon an agreement of the contracting parties or their legal successors in title.
- 4. The Publisher is not authorised to refer the rights and obligations of this agreement to the third party.
- 5. This agreement shall be governed by and construed in accordance with the Copyright Law and Civil Code as amended.
